The NIBL FQAS Product Standard requires that “Records of purchased and home-grown feedstuffs must be kept” (code 3.17). For purchased compound feeds and supplements a record must be kept of the ingredient composition, for example by retaining bag labels or invoices (code 3.16). For home-mixed rations, a record of the formulation must be kept (code 3.17). For animal feed materials or crop by-products that might be used for straight feeding or for incorporation in a home-mix, the name of the supplier must be kept (code 3.17). The records should be kept in the format shown in this booklet, but may be kept on a personal computer provided the same format is used and a suitable back-up system is in place (code 3.17).
